**COUNT 1:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did attempt to commit the crime of Murder, to wit: to knowingly or intentionally kill another human being, to wit: Richard Dunigan, and did, with the intent to kill, knowingly or intentionally strike Richard Dunigan with a motor vehicle, which constituted a substantial step toward the commission of the crime of Murder, in violation of I.C. 35-42-1-1(1) and I.C. 35-41-5-1(a).

**COUNT 2:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did attempt to commit the crime of Murder, to wit: to knowingly or intentionally kill another human being, to wit: Ron May, Jr., and did, with the intent to kill, knowingly or intentionally strike Ron May, Jr. with a motor vehicle, which constituted a substantial step toward the commission of the crime of Murder, in violation of I.C. 35-42-1-1(1) and I.C. 35-41-5-1(a).

**COUNT 3:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did knowingly or intentionally inflict injury on a person, to wit: Richard Dunigan, that created a substantial risk of death or caused serious permanent disfigurement or the protracted loss or impairment of the function of a bodily member or organ, in violation of I.C. 35-42-2-1.5(1) or (2).

**COUNT 4:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did knowingly or intentionally inflict injury on a person, to wit: Ron May, Jr., that created a substantial risk of death or caused serious permanent disfigurement or the protracted loss or impairment of the function of a bodily member or organ, in violation of I.C. 35-42-2-1.5(1) or (2).

**COUNT 5:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker knowingly or intentionally touched another person, to wit: Angel Kelley Monday, in a rude, insolent or angry manner, and said offense was committed with a deadly weapon, a motor vehicle, in violation of I.C. 35-42-2-1(c)(1) and I.C. 35-42-2-1(g)(2).

**COUNT 6:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker, being the driver of a vehicle that was involved in an accident with Richard Dunigan did fail to stop at the scene of the accident or remain at the scene of the accident or provide reasonable assistance to each person injured or entrapped by the accident, and the accident resulted in moderate or serious bodily injury to Richard Dunigan, in violation of I.C. 9-26-1-1.1(a)(3) and I.C. 9-26-1-1.1(b)(2)(A).

**COUNT 7:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker, being the driver of a vehicle that was involved in an accident with Ron May Jr. did fail to stop at the scene of the accident or remain at the scene of the accident or provide reasonable assistance to each person injured or entrapped by the accident, and the accident resulted in moderate or serious bodily injury to Ron May Jr., in violation of I.C. 9-26-1-1.1(a)(3) and I.C. 9-26-1-1.1(b)(2)(A).

**COUNT 8:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did knowingly or intentionally exert unauthorized control over a 2004 Chevrolet truck, the motor vehicle of Jack Hostetter, with the intent to deprive Jack Hostetter of the vehicle's value or use, in violation of I.C. 35-43-4-2(a) and I.C. 35-43-4-2(a)(1)(B)(i).

**COUNT 9:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did knowingly or intentionally exert unauthorized control over a 2023 Kia Forte, the motor vehicle of Samantha Farrell, with the intent to deprive Samantha Farrell of the vehicle's value or use, in violation of I.C. 35-43-4-2(a) and I.C. 35-43-4-2(a)(1)(B)(i).

**COUNT 10:**

The undersigned says that on or about April 20, 2024, in Vigo County, State of Indiana, Dustin Lee Roecker did knowingly flee from Gerald Stump and/or Cogan McClain and/or Ron Elliott, a law enforcement officer, after said officer identified himself by visible or audible means and visibly or audibly ordered Dustin Lee Roecker to stop and in committing said act Dustin Lee Roecker used a vehicle, in violation of I.C. 35-44.1-3-1(a)(3) and I.C. 35-44.1-3-1(c)(1)(A).
